The Department of Commerce shall promulgate rules to establish the required elements of the loan application under (2)(f) and the required contents of the interim report under (3)(a) and the comprehensive evaluation under (3)(b). The application under (2)(f) shall include at a minimum, all of the following: a brief description of the borrower's type of business; the primary purpose for which the loan will be used; the borrower's current number of full-time and part-time employees; the number of full-time and part-time jobs the borrower expects will be created, retained or substantially upgraded as a result of the activity financed by the loan; the borrower's current annual sales; the percentage of the business that is owned by minorities; the percentage of the business that is owned by women; the borrower's current number of minority employees; and the borrower's current number of female employees.

The comprehensive evaluation under (3)(b) shall include an aggregation of all the information provided in the applications under (2)(f).

(3)(b) No later than ~~June 30, 2013~~, December 31, 2012, a comprehensive evaluation of the program.
