1 AN ACT *to repeal* 29.569 (2); and *to amend* 29.569 (1) of the statutes; **relating**  
2 **to:** hunting of deer during the open bow hunting season. ✓

---

***Analysis by the Legislative Reference Bureau***

Current law, with limited exceptions, prohibits a person who is issued a deer hunting license that authorizes hunting deer with a bow and arrow during the open deer bow hunting season from using the license until three days after it is issued. This bill repeals this prohibition.

---

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

3 SECTION 1. ✓ 29.569 (1) of the statutes is amended to read:  
4 29.569 (1) SPECIFICATION OF EFFECTIVE PERIODS; RESTRICTIONS. Unless an  
5 approval issued under this chapter is suspended or revoked or unless another section  
6 of this chapter specifically provides otherwise, the approval is valid for the period or  
7 season specified on the face of the approval or on an attachment to the approval. In  
8 addition to any other restriction under this chapter, no license may be issued if that  
9 issuance is restricted under sub. ~~(2)~~ or (3).
