The Honorable, The Senate:

Pursuant to 2009 Act 28 section 91.37 (2)(i), the Legislature's standing committees with jurisdiction over agricultural matters are required to report recommendations for the imposition of Wisconsin Pollution Discharge Elimination System (WPDES) application fees for Confined Animal Feeding Operation (CAFO) to the presiding officers of the Legislature. As Chair of the Senate Committee on Agriculture and Higher Education, I write to satisfy this requirement.

Currently, the Department of Natural Resources is engaged in on going conversations with stakeholder groups regarding WPDES permit fees for CAFO operators. The stakeholder groups represent a broad spectrum of interested parties, including groups representing environmental and agricultural interests. Theses conversations are essential to develop viable policy recommendation that address the issues raised during the most recent budget process.

The Senate Committee on Agriculture and Higher Education will continue to monitor this effort and stands ready to offer recommendation as they become available.

The Honorable, The Legislature:

This report is transmitted as required by s. 20.002(11)(f), Wisconsin Statutes, (for distribution to the appropriate standing committees under s. 13.172(3), Wisconsin Statutes) and confirms that the Department of Administration has found it necessary to exercise the "temporary reallocation of balances" authority provided by this section in order to meet payment responsibilities and cover resulting negative cash balances during the month of May 2010.

On May 1, 2010, the <u>Utility Public Benefits Fund</u> cash balance closed at a negative \$6.7 million. This negative balance continued through May 31, 2010, when the fund's cash balance closed at a negative \$7.3 million (its intra—month low). The negative balance was due to the difference in the timing of revenues and expenditures.

On May 1, 2010, the <u>Medical Assistance Trust Fund</u> cash balance closed at a negative \$309.0 million (its intra-month low). This negative balance continued through May 31, 2010, when the fund's cash balance closed at a negative \$307.7 million. The negative balance was due to the difference in the timing of revenues and expenditures.

On May 1, 2010, the <u>Police and Fire Protection Fund</u> cash balance closed at a negative \$13.9 million (its intra—month low). This negative balance continued through May 31, 2010, when the fund's cash balance closed at a negative \$12.9 million. The negative balance was due to the difference in the timing of revenues and expenditures.

The Utility Public Benefits Fund, Medical Assistance Trust Fund, and Police and Fire Protection Fund shortfalls were not in excess of the statutory interfund borrowing limitations and did not exceed the balances of the funds available for interfund borrowing.

The distribution of interest earnings to investment pool participants is based on the average daily balance in the pool and each fund's share. Therefore, the monthly calculation by the State Controller's Office will automatically reflect the use of these temporary reallocations of balance authority and, as a result, the funds requiring the use of the authority will effectively bear the interest cost.
