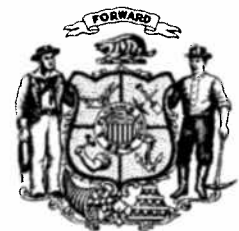

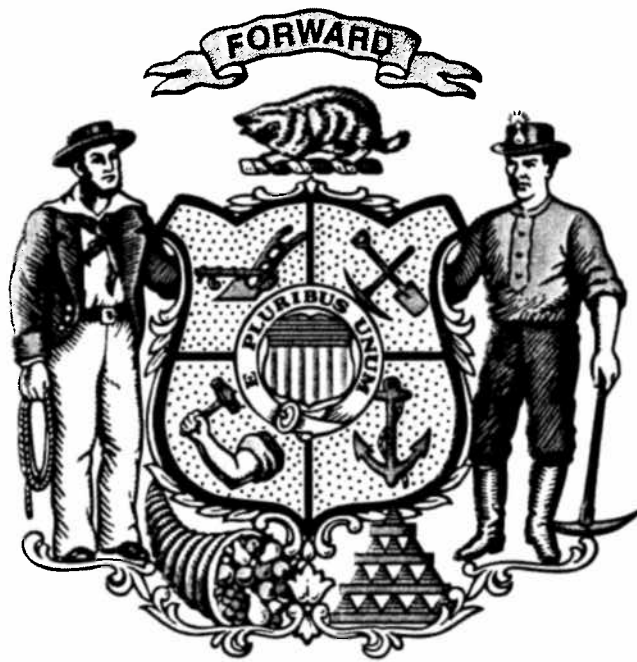

RE: Assembly Bill 578, Healthy and environmentally sensitive cleaning in certain buildings, providing an exemption from emergency rule procedures, and granting rule-making authority.

Chairperson Black and Members of the Committee,

Thank you for holding a public hearing today on a bill I authored, Assembly Bill 578, related to the Healthy and environmentally sensitive cleaning in certain building, providing an exemption from Emergency rule procedures, and granting rule-making authority.

The goal of this bill is to encourage healthier and more environmentally friendly cleaning standards for our schools and other public buildings. According to the U.S. Environmental Protection Agency (EPA), half of students may be exposed to polluted indoor air, lead, asbestos, chemical fumes, pesticides, molds and other toxins, along with overcrowding and poor sanitation.

Many of us spend our time working or studying indoors and we should ensure our indoor environments are healthy, safe, and clean. Research has shown that children's lungs are much more susceptible to the negative health effects of harsh cleaning chemicals. As a parent I want to know that my daughter will not only learn in a creative environment, but, also in a safe, clean environment free of toxic chemicals.

This bill would empower the Department of Health Services (DHS) to create a council on Healthy & Environmentally Sensitive Cleaning which would consult with DHS about the product standards for cleaning processes and products. DHS would follow suggestions from national environmental organizations who have researched and implemented cleaning standards for their products and set guidelines in other states like Illinois and New York.

Let's take the right steps to ensure healthy and environmentally safe spaces for children, employees, and other building occupants and the environment.

RE: Assembly Bill 578 – Green Cleaning Bill

This memo addresses Assembly Bill 578, the “green cleaning” legislation introduced by Representative Mason. Georgia-Pacific appreciates the effort to improve indoor air quality in our schools and other public buildings, but objects to language in the bill which requires those facilities to use specific types of paper products. We believe this mandate is unnecessarily prescriptive and has the potential to add costs to papermakers selling their product in Wisconsin.

Georgia-Pacific, LLC is a worldwide leader in the production of paper products. The company manufactures tissue and other paper products for the retail and “away from home” markets at its two mills in Green Bay. G-P also operates packaging, conversion and distribution facilities in five other cities in Wisconsin. The company employs 3,700 people in Wisconsin.

Georgia-Pacific is an industry leader that is committed to recycling. Its Green Bay mills recycle more than 475,000 tons of paper product every year. The Broadway mill recycles more tissue than any other mill in the world.

Assembly Bill 578 requires that state and local government buildings, including schools (public and private) use toilet paper, paper napkins and paper towels that have been approved by specific private organizations in the business of creating environmental standards for janitorial and sanitation products (e.g., Green Seal, Inc. and TerraChoice Environmental Marketing, Inc.). The legislation also grants the Department of Health the power to choose only one applicable standard and to revise it at a later date.

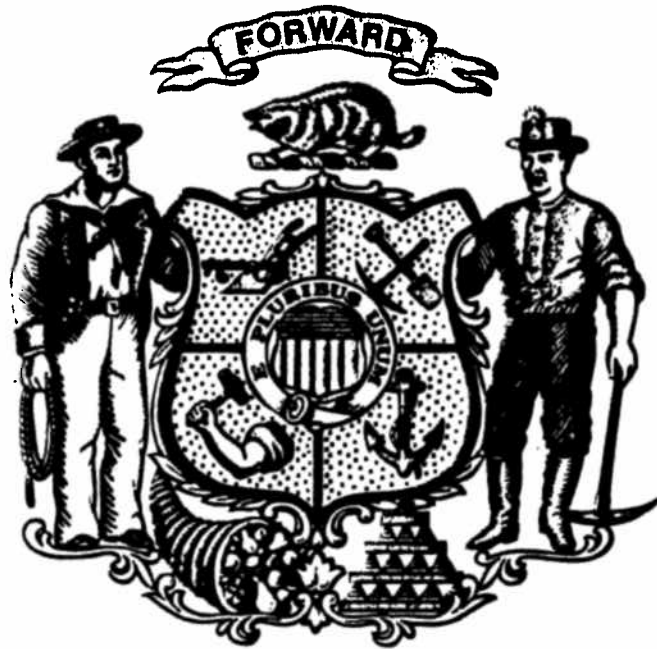
As currently drafted, the legislation could ultimately result in procurement standards that would make it difficult or impossible for G-P to supply janitorial paper products to public facilities and private schools in Wisconsin. Although G-P and other papermakers may be able to meet one of the standards currently listed (e.g., EcoLogo), the bill gives the Department of Health the authority to initially set a single standard other than EcoLogo and then to change that standard at a later date. This lack of predictability, limitation of options and possibility of shifting standards will make it difficult for papermakers to plan ahead to supply products to the listed facilities. It also means those companies may incur costs to adjust to the new standards, only to have them revised when the Department of Health discovers, for example, a new toilet paper standard.

In order to establish standards, the bill relies on private third party organizations that are neither accountable nor transparent to the public. The legislation then empowers the Department of Health to change those standards after consulting with an appointed council. We believe there are insufficient checks in place to ensure that the practical impacts of this convoluted standard-setting process are fully considered.

The bill was apparently designed to address indoor air quality issues that arise from cleaning schools and other public facilities. The language about cleaning chemicals and processes speaks to that concern. However, what type of toilet paper is used at city hall has no impact on the core issue of this bill. The paper mandate can easily be removed from the legislation without injuring its intent to require green cleaning.

Although G-P cannot support AB 578 as currently drafted, we would be happy to sit down with members of the committee and the author to discuss the legislation further.

Introduction and Overview

The Soap and Detergent Association (SDA) provides the following comment regarding Wisconsin Assembly Bill 578. SDA is a trade association representing the \$30 billion U.S. cleaning products market. SDA members include the formulators of soaps, detergents, and general cleaning products used in household, commercial, industrial and institutional settings; companies that supply ingredients and finished packaging for these products; and oleochemical producers. SDA is the association for cleaning products, and the soap and detergent industry develops products that meet or exceed safety requirements of all state and federal agencies in the United States.

SDA and its members are dedicated to improving health and the quality of life through sustainable cleaning products and practices. Our mission is to support the sustainability of the cleaning product and oleochemical industries through research, education, outreach and science-based advocacy. Founded in 1926, a major component of the SDA mission has been the promotion of improved health through personal hygiene and effective cleaning.

SDA Is Engaged in Promoting Cleaning and Health

Ensuring human health and environmental safety are priorities for SDA members. Sound, technical research has demonstrated the safe and beneficial use of cleaning products and their ingredients when properly used. The health benefits of cleaning products are undisputed, and the historical correlation between improved personal hygiene and reduced infant mortality rates and disease reduction are well established. SDA works closely with the Centers for Disease Control and Prevention (CDC) and many other public and private entities in promoting public health. Two examples demonstrate this commitment:

- SDA works in cooperation with the CDC on the “*Healthy Schools, Healthy People It’s a SNAP*” (*School Network for Absenteeism Prevention*) program. The program features an annual national contest with middle schools competing to develop the most effective communication program demonstrating that handwashing is essential to breaking the chain of disease transmission. The SDA and CDC work together as partners to bring the winning school to Washington, DC for an award presentation.
- SDA has also teamed up with the National Education Association (NEA) Health Information Network and the CDC to create the National *C.L.E.A.N.*[™] - *Custodial Leaders for Environmental Advocacy Nationwide* award to recognize the contributions that custodians make to public health in their schools, communities, and their profession.

More information on both of these collaborative programs, SDA sustainability efforts, as well as many other initiatives, including information on the cleaning products industry can be found at www.cleaning101.com.

SDA Is Substantively Engaged on Environmentally Preferable Procurement Policy Issues

SDA and its members have participated in several activities with national impact. These include participation in the development of the ASTM Standard “*Guide for Stewardship for the Cleaning of Commercial and Institutional Buildings*.” SDA would note that the guide assists owners and operators of commercial and institutional buildings in the stewardship of cleaning and housekeeping operations. It maximizes eco-efficiency and is designed to minimize adverse impacts on building occupants, cleaning personnel, the building structure itself, and the environment.

SDA would point to the successful efforts of the U.S. Environmental Protection Agency's Design for the Environment (DfE) program for environmentally preferable purchasing and procurement programs. At the federal governmental level, SDA is working with the Design for the Environment program and in particular, the *Formulator Program*. The DfE program gathers hazard information on chemical ingredients and works within the EPA Office of Pollution Prevention and Toxics (OPPT) and science experts from other EPA offices to assess information and compare the relative hazards of chemicals. In addition, SDA has worked with the EPA on drafting its *Guidance on Environmentally Preferable Purchasing*.

SDA has also commented on important work at the U.S. Federal Trade Commission (FTC) regarding environmental marketing claims. An important element in any effective green cleaning program is accurate product claims. The FTC publishes official guidelines, "*Guides for the Use of Environmental Marketing Claims*" for consumer products, and SDA has been an active participant in agency update and review of the guides. SDA would note that the term 'green' has not been scientifically evaluated and is a marketing claim that has many meanings to many people, such that the Federal Trade Commission (FTC) is reviewing its environmental marketing guidance in an effort to help reduce confusion.

SDA Recommendations on Environmentally Preferable Procurement

SDA has been substantially engaged in environmentally preferable procurement issues at the state and federal levels, and has lengthy experience with program development. SDA has opposed simplistic pass/fail approaches, and does not believe that the purchasing of the cleaning products approved by existing certification programs would lead to demonstrative environmental improvements. Such approaches could negatively impact the environment by not allowing innovative products which may have better environmental and human health profiles to be used. SDA recommends the adoption of guidelines that allow for DfE recognized products, as well as products which meet a company's internal standards for human and environmental health and safety.

As a succinct summation to the considerations noted throughout the course of these comments, SDA provides three general guiding recommendations:

1. Accurate and meaningful information should be utilized in procurement decisions.
2. Purchasing decisions should be based on consideration of environmental factors *plus price plus* performance.
3. Relative environmental impacts should be compared with pollution prevention considered at all stages of the process.

SDA Comments on Wisconsin Assembly Bill 578

It is the aim of SDA to achieve the application of sound science in making purchasing decisions; to maintain clarity in the possible development of any environmentally preferable requirements or criteria; and, the flexibility to recognize innovation. SDA encourages a flexible approach taking into consideration market-based approaches and solutions that address environmental and state procurement issues.

The legislation addresses certain cleaning products utilized in state and publicly owned buildings with a focus on health and the environment. The proposed legislation would require new rules written by the Department of Health Services in consultation with a legislatively mandated council. SDA urges the consideration of the following issues and comments with regard to these provisions.

AB 578 provides for a state-wide development of rules; SDA commends this approach as it is of the utmost importance to avoid a patchwork-quilt of rules and requirements -- individual local or regional action will only strain already limited budgets. SDA also recommends that the product scope of the legislation focus on hard-surface cleaning and maintenance products.

SDA recommends any environmentally preferable purchasing program allow maximum flexibility. Such a program should not require singular state reliance on any one type of third-party standard, certification or recognition program. While AB 578 approaches this goal, several provisions do not provide this level of flexibility. SDA specifically does not agree with provisions in Section (2)(b)(1) under provisions for initial rules for products for janitorial or sanitation use requiring that the department "shall include a requirement to use hand cleaners and hand soap approved by Green Seal." SDA would note that antimicrobial hand soaps and sanitizers are regulated by the Environmental Protection Agency and are necessary in certain school areas such as nurse's stations and food preparation areas.

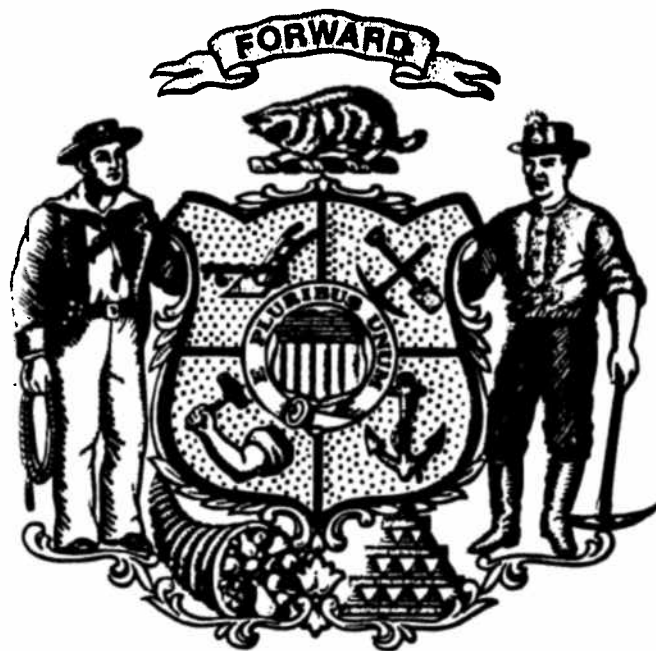
Of note with regard to third-party entities, SDA has commented to Green Seal, Inc. on several standards proposals and has urged the organization to consider criteria beyond simply hazard-based approaches of various product standards. Further, during the development of the August 2008 revision of the GS-37 standard, it should be noted that this revision was not consensus-driven and, therefore, may not contain criteria that are scientifically-based where true environmental and human health and safety impacts may occur. This standard provides a much lower level of safety and environmental protection than exposure and risk-based safety assessment methodologies widely used by the soap and detergent industry to assess the safety of products on a routine basis. Exposure and risk-based assessment often considers many more endpoints including sorption, wastewater treatment removal, overall exposure (total volumes emitted to the environment and concentration at target sites), long-term toxicity, and bioaccumulation. As with other similar Green Seal standards, this one also provides a set of stagnant criteria that do not change in time, and ignores progress in technology and innovation: this can be a hurdle to innovation, which may potentially lead to more effective cleaning products with real environmental improvements.

SDA would be pleased to work with members of the Committee and the balance of the Legislature on these specific recommendations as well as other aspects of the legislation.

Conclusion

SDA appreciates the opportunity to share its experience and knowledge with the State of Wisconsin. SDA is the association for cleaning products, and stands ready to serve as a resource to any state-based entity in this regard. Human health and environmental safety are priorities for SDA members, and throughout its history, the association's sound, technical, risk-based research has demonstrated the safe, beneficial, and proper use of cleaning products and their ingredients. SDA members take pride in formulating safe and efficacious products.

SUBJECT: Opposition to Assembly Bill 578

The Wisconsin Counties Association (WCA) opposes Assembly Bill 578, pertaining to cleaning of buildings owned by local governments (counties, municipalities, and school districts).

WCA supports environmental initiatives and healthy workplaces. We acknowledge that the cleaning products used in government offices and schools can affect the environment and the health of those working and studying in these facilities. However, we have concerns about the effects of AB 578 on county operations. Because of these concerns we oppose the bill.

We have not been able to determine whether additional county costs would be associated with the passage of AB 578. We urge greater study of this issue before this bill is given a vote by the Assembly. Given recent cuts to shared revenue, increased pressure on the property tax base, the continuing existence of levy limits and tax rate limits facing counties, and the increasing demands being made on county levy revenues by existing state-mandated programs, counties are sensitive to any potential increase in operating expenses.

WCA also believes that the requirements to use specific cleaning supplies and systems as laid out in AB 578 are excessive. While the goals of AB 578 are laudable, the bill is highly prescriptive. At a minimum, the bill would impose yet another set of rules on what counties may do and how they may do it. This can only add an administrative burden to local governments' duties.

WCA believes that the potential effects on AB 578 on local governments (including schools) are unpredictable. The implications seem likely to be both budgetary and administrative. In passing, we believe that the bill will also bring unpredictable implications for manufacturers and suppliers of cleaning products and systems.

Because of increasing awareness of the need for "green" cleaning and maintenance, changes are already occurring in the areas of cleaning and in disposal. WCA supports these changes, but we believe that this trend makes AB 578 less necessary than it might otherwise be.

We therefore express our opposition to AB 578.

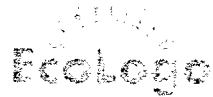
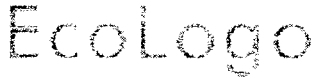


