Mayor, City of Mequon, Mequon WI

Elected April 1998; re-elected unopposed in 2001, 2004 and 2007.

Chief Executive Officer, City of Mequon

- Established a visioning process that has led to widely supported community initiatives with regard to housing, road design, management of commercial development, and preservation of green space.
- Working cooperatively with Ozaukee Washington Land Trust and Greater Milwaukee Foundation to establish 438 acre nature preserve in Mequon bordering the City of Milwaukee. Facility is becoming premier educational, research and recreation site. As part of this effort have established the PieperPower Education Center which will be the first "green" LEED building in the City of Mequon.
- Raising private funds as part of a public/private partnership to further city goals. Have raised \$10.1 million to fund Mequon Nature Preserve and working to secure another \$2.5 million.
- Established a Transfer of Development Rights (TDR) program and completed what appears to be the first TDR transaction in the State of Wisconsin. Also promoted and oversee planning for conservation subdivisions in rural, unsewered area of City.
- Proposed and promoted working with the Village of Thiensville to create a Town Center as part of an economic redevelopment effort for both the City of Mequon and the Village of Thiensville. Joint Committee has completed plans for area including street scaping and other physical improvements, architectural guidelines, and parking program—all in anticipation of creating a TID in 2008. In 2007 City adopted a Town Center zoning district and rezoned Town Center area properties without protest by any land owner.
- Chaired group of chief elected officials to provide guidance to the Legal Subcommittee to resolve issues between the Wisconsin Attorney General (AG) and 28 communities. The AG threatened litigation over MMSD bypassing in 2004.
