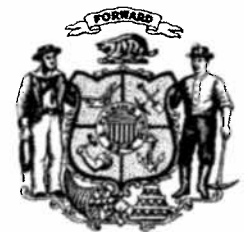


I write to you in support of Assembly Bill 153 that proposes to amend the statutes concerning State Fair Park Board membership.

Department of Tourism representation on the State Fair Park Board brings critical state government integration to the function and promotion of the park and its events. However, as Secretary my schedule often does not permit me to attend every board and committee meeting. In those rare times that I am unable to attend, having flexibility to send a Department representative in my absence provides much needed continuity and consistency to the board.

Assembly Bill 153 modifies the statute to allow the Secretary of Tourism to provide a designee in their absence. I envision my designee would be the Tourism Deputy Secretary for those opportunities that I am unable to attend board meetings and the Tourism Marketing and Communications Director in the case of marketing committee meetings. Both designees would serve State Fair Park Board well in my absence in terms of their functions and roles within the Department of Tourism.

I thank you for the opportunity to lend my support to this worthwhile bill, which will better serve the interests of State Fair Park.

Your Committee will consider Assembly Bill 153 on Wednesday, April 15, 2009. The Wisconsin State Fair Park Board and its management fully support the proposed legislation that would allow two of its board members (the Secretary of the Department of Tourism and the Secretary of the Department of Agriculture, Trade and Consumer Protection) to appoint a designee to represent them on the Board if they are not available.

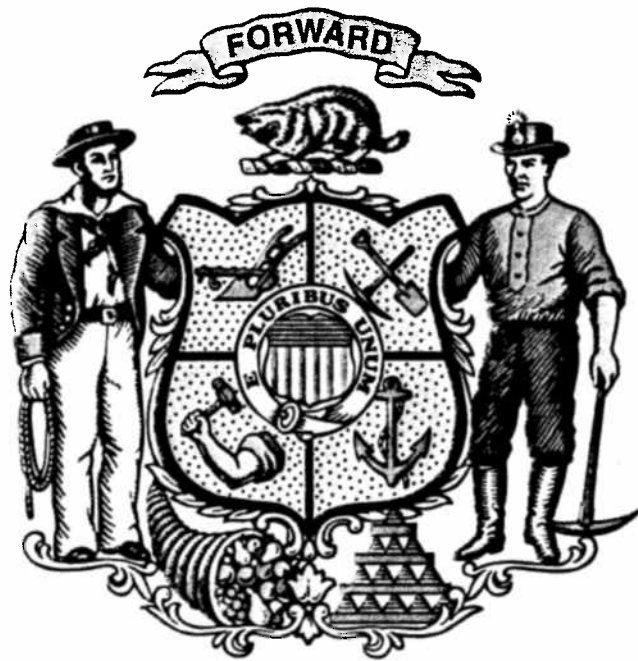
State Fair Park was originally attached to the Department of Agriculture, Trade and Consumer Protection and is currently attached to the Department of Tourism. These associations reflect the State Fair's important roles in the State's agriculture and tourism industries as well as the strong working relationship between these agencies and State Fair Park. Chairman Holperin and members, thank you for allowing me the opportunity to share with you my support for Assembly Bill 153, a proposal relating to the membership of the State Fair Park Board.

In the 1999 Legislative Session, the State Fair Park governance underwent the most extensive statutory revisions and comprehensive renovation in its over 100 years of history. At that time, the State Fair Park Board was expanded, and members with certain areas of expertise were specified for appointment to the Board.

Because of the State Fair Park's rich history in our state's agriculture and tourism industries, the Secretary of the Department of Agriculture, Trade and Consumer Protection and the Department of Tourism were added to the membership of Board. Prior to this reorganization, the State Fair Park was statutorily attached to the Department of Tourism. However, the Secretary was not a board member.

Assembly Bill 153 addresses these two specific, cabinet-level appointees. This proposal allows the Secretaries of both DATCP and Tourism to designate an employee within their respective departments to serve on the State Fair Park Board and vote on their behalf.

The Secretaries of each of these departments shoulder a great deal of responsibility not only in their offices but around the state. Allowing them the ability to appoint an employee from their department to the State Fair Park Board provides them with input without the significant demands on their limited time.

Assembly Bill 153 is identical to last session's AB 896 which received a unanimous vote on the floor of the Assembly but failed to be acted on by the Senate prior to the conclusion of the legislative session. AB 153 received unanimous votes in the Assembly Committee on Tourism, Recreation and State Properties and on the Assembly floor.
