TO SENATE BILL 1**

January 20, 2011 – Offered by Representatives STASKUNAS and RADCLIFFE.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 30, line 6: after that line insert:

3 **“SECTION 44m. Fiscal changes.**

5 under section 20.005 (3) of the statutes for the appropriation to the department of

7 2011, the dollar amount is increased by \$100,700 for fiscal year 2011–12 to increase
8 the authorized FTE assistant district attorney position in Brown County by 1.0 GPR
9 position to manage additional workload generated by sections 907.01 and 907.02 of
10 the statutes, as affected by this act, including expert witness hearings held pursuant
11 to section 907.02 of the statutes, as affected by this act. In the schedule under section
12 20.005 (3) of the statutes for the appropriation to the department of administration
13 under section 20.475 (1) (d) of the statutes, as affected by the acts of 2011, the dollar

24 statutes, as affected by this act. In the schedule under section 20.005 (3) of the
25 statutes for the appropriation to the department of administration under section

2 increased by \$108,000 for fiscal year 2012-13 to provide funding for the position

4 (6) ASSISTANT DISTRICT ATTORNEY POSITION; POLK AND ST. CROIX COUNTIES. In the

6 department of administration under section 20.475 (1) (d) of the statutes, as affected
7 by the acts of 2011, the dollar amount is increased by \$100,700 for fiscal year 2011-12
8 to increase the total number of authorized FTE assistant district attorney positions
9 in Polk and St. Croix counties by 1.0 GPR position to manage additional workload
10 generated by sections 907.01 and 907.02 of the statutes, as affected by this act,
11 including expert witness hearings held pursuant to section 907.02 of the statutes, as
12 affected by this act. In the schedule under section 20.005 (3) of the statutes for the
13 appropriation to the department of administration under section 20.475 (1) (d) of the
14 statutes, as affected by the acts of 2011, the dollar amount is increased by \$108,000
15 for fiscal year 2012-13 to provide funding for the position authorized under this
16 subsection.”.
