**ASSEMBLY AMENDMENT 1,
TO 2011 SENATE BILL 219**

March 15, 2012 – Offered by Representative BALLWEG.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 6, line 22: after that line insert:

3 “**SECTION 4m.** 20.445 (1) (v) of the statutes, as created by 2011 Wisconsin Act
4 (this act), is repealed.”.

5 **2.** Page 7, line 1: after that line insert:

6 “**SECTION 6m.** 25.17 (1) (xf) of the statutes, as created by 2011 Wisconsin Act....
7 (this act), is repealed.”.

8 **3.** Page 8, line 23: delete the material beginning with that line and ending with
9 page 9, line 2.

10 **4.** Page 12, line 18: delete the material beginning with that line and ending
11 with page 13, line 2.

12 **5.** Page 13, line 5: delete lines 5 to 13.

1 **6.** Page 16, line 12: after that line insert:

2 “**SECTION 37m.** 108.19 (1s) of the statutes, as created by 2011 Wisconsin Act ...
3 (this act), is repealed.”

4 **7.** Page 17, line 8: delete lines 8 to 12.

5 **8.** Page 17, line 16: delete “, a liability incurred under s. 108.04 (11) (bh)”.

6 **9.** Page 17, line 19: delete the material beginning with that line and ending
7 with page 18, line 9.

8 **10.** Page 18, line 24: delete the material beginning with that line and ending
9 with page 19, line 2, and substitute:

10 “(1) The treatment of sections 20.445 (1) (v) (by SECTION 4), 25.17 (1) (xf) (by
11 SECTION 6), 108.04 (11) (a), (b), (be), and (bm), 108.16 (6) (f), and 108.19 (1s) (by
12 SECTION 37) of the”.

13 **11.** Page 19, line 5: after that line insert:

14 “(1g) The creation of sections 20.445 (1) (v), 25.17 (1) (xf), and 108.19 (1s) of the
15 statutes first applies with respect to overpayments established by the department
16 of workforce development after the effective date of this subsection.

17 “(1r) The repeal of sections 20.445 (1) (v), 25.17 (1) (xf), and 108.19 (1s) of the
18 statutes first applies with respect to overpayments established by the department
19 of workforce development after October 21, 2013.”.

20 **12.** Page 20, line 8: delete the material beginning with “(with” and ending
21 with “statutes)” line 9.

22 **13.** Page 20, line 12: delete lines 12 and 13 and substitute:
