“Before the common council may adopt a resolution approving the sale or lease of underutilized city-owned property used for school purposes, the common council shall adopt a set of criteria under which the common council may or may not find that the city-owned property is underutilized.

In order to determine whether property meets the adopted criteria, the common council shall request from the board, and the board shall provide within 15 days, all relevant information regarding the current and planned utilization of city-owned property used for school purposes that is being contemplated for sale or lease.”
