1 AN ACT *to amend* 77.54 (30) (a) 2. of the statutes; **relating to:** the sales and use
2 tax exemption for electricity and natural gas. ✓

Analysis by the Legislative Reference Bureau

Under current law, ✓ electricity and natural gas sold during the months of November, December, January, February, March, and April for residential use is exempt from the sales and use tax. ✓ Under this bill, electricity and natural gas sold for residential use is exempt from the sales and use tax, regardless of when it is sold. ✓

Because this bill relates to an exemption from state or local taxes, ✓ it may be referred to the Joint Survey Committee on Tax Exemptions for a report to be printed as an appendix to the bill. ✓

For further information see the ***state and local*** fiscal estimate, which will be printed as an appendix to this bill. ✓

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 77.54 (30) (a) 2. of the statutes is amended to read: ✓

4 77.54 (30) (a) 2. Electricity and natural gas sold ~~during the months of~~
5 ~~November, December, January, February, March and April~~ for residential use. ✓

6 SECTION 2. **Effective date.**
