1. Page 1443, line 17: after that line insert:

~~(20)~~ ⁽⁷⁾ WORK RELEASE; INCREASES. The department of corrections shall increase, in a county having a population of 750,000 or more, the number of participants in a work release program under section 303.065 of the statutes by 200 in fiscal year 2011-12 and by 200 in fiscal year 2012-13.

~~(20)~~ ⁽²⁾ TREATMENT PROGRAM; INCREASES. The department of corrections shall increase, in a county having a population of 750,000 or more, the number of participants in a program under section 302.05 of the statutes by 200 in fiscal year 2011-12 and by 200 in fiscal year 2012-13.
