6 "29.037 (2) On or before March 15 of each even-numbered year, the department
7 shall submit to the chief clerk of each house of the legislature for distribution to the
8 appropriate standing committees under s. 13.172 (3), a report identifying the
9 department's use and expenditure of funds provided to the department under 16
10 USC 669 to 669k or 777 to 777L."
