Hi Tim,

Thank you again for giving us the opportunity to review this amendment. We believe that this amendment accomplishes your goals, as we understand them. We would suggest one minor change:

Para 348.25(7), is added in the LRB, but should be removed. We think it was intended to disallow the department's ability to suspend during spring thaw. It is actually, by its terms and in practice, used only to suspend permits for misbehavior by the permittee. It is not the basis for spring thaw or other seasonal permit suspensions. The authority of (7) to suspend for misbehavior is used exceedingly sparingly, only 5 times in 20 years, one of which was followed by a felony conviction of the permittee.

The language in the amendment is complex, and we are certainly available to provide input to the drafter on ways to streamline and simplify them while maintaining your legislative intent. If you are interested in our assistance in that regard, please let me know.
