1 **AN ACT ...; relating to: photographs on operator's licenses.**

***Analysis by the Legislative Reference Bureau***

Under current law, a motor vehicle operator's license must include a color photograph of the licensed person. Under this bill, the license must include a photograph of the licensed person, but the photograph need not be in color.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

2 **SECTION 1.** 343.17 (3) (a) 2. of the statutes is amended to read:

3 343.17 (3) (a) 2. A color photograph of the person.

NOTE: NOTE: Subd. 2. is amended by 2011 Wis. Act 23 effective the date stated in the notice provided by the secretary of transportation and published in the Wisconsin Administrative Register under section 85.515 (2) (b) to read:NOTE:

4 2. A color photograph of the person, unless the exception under s. 343.14 (3m) applies.
