3 Except as provided in par. (b), a".

4 2. Page 5, line 2: after that line insert:

5 "(b) A rental-purchase company that generates less than 75 percent of its total
6 revenues in this state from transactions involving rental-purchase agreements may
7 elect not to file notice with the department under par. (a) and, upon informing the
8 department of this election in a manner prescribed by the department, shall not be
9 governed by the provisions of this chapter."
