Whereas Reince Priebus was born on March 18, 1972 to Richard and Dimitra Priebus and was raised in Kenosha, Wisconsin.

Whereas Reince Priebus' earliest political aspirations began in third grade at Pleasant Prairie Elementary School where he was the self-appointed manager of Ronald Reagan's presidential bid.

Whereas by age sixteen Reince Priebus began volunteering for political campaigns and graduated from George Nelson Tremper High School in 1990.

Whereas Reince Priebus obtained a bachelor's degree in Political Science and English in 1994 from the University of Wisconsin – Whitewater where he was student body president.

Whereas Reince Priebus worked in the Wisconsin Legislature for a year and then went to law school receiving a law degree from the University of Miami School of Law in 1998.

Whereas during his time in law school he clerked for the Wisconsin Court of Appeals, the Supreme Court of Wisconsin, the United States District Court Southern District of Florida, and interned for the NAACP legal defense fund. Move lines 10-15 on page 3 after line the line above on page 2. ✓


