Whereas, Dick served the city of Oak Creek as an elected official for nearly a decade, first as alderman of the 4th District, serving from 2002 to 2003, and then as mayor for three terms from 2003 to 2011; and

Whereas, during his tenure as mayor of Oak Creek, Dick was instrumental in many redevelopment projects, including the 85-acre former Delphi site, opening the lakefront area for public access, facilitating Bucyrus International headquarters (now Caterpillar) moving to Oak Creek, and recruiting redevelopment along South Howell Avenue which included Woodman's grocery store; and

Whereas, Dick was well respected as an honest public servant and was always accessible to the community, holding regular "meet the mayor" sessions at city hall and the countless meetings in living rooms of Oak Creek residents; and

Whereas, Dick had announced his retirement, wanting to spend more time with his family, just one week before his untimely passing; and

Whereas, Dick was a devoted husband and friend to Christine, father to Michael and Lisa, and grandfather to Brittany, Cindy, Brianna, Taylor, Robby, and Madison; now, therefore, be it
