1 At the locations indicated, amend the bill as follows:

3 "(2m) LAYOFFS, FURLOUGHS, OR REDUCTIONS IN HOURS. Before January 1, 2014,  
4 no governmental employer in this state may layoff, require an unpaid furlough, or  
5 impose any reduction in work hours for a ~~public sector~~ employee."
