1. Page 134, line 15: after that line insert:

“(2m) LAYOFFS, FURLOUGHS, OR REDUCTIONS IN HOURS. Before January 1, 2014,
no ~~governmental employer~~ in this state may layoff, require an unpaid furlough, or
impose any reduction in work hours for a ~~public sector~~ employee.”
