ASSEMBLY AMENDMENT,  
TO ASSEMBLY BILL 11

1 At the locations indicated, amend the bill as follows:

2 1. Page 134, line 15: after that line insert:

3 "(2m) LAYOFFS, FURLOUGHS, OR REDUCTIONS IN HOURS. Before January 1, 2014,  
4 no governmental employer in this state may layoff, require an unpaid furlough, or  
5 impose any reduction in work hours for a public sector employee."

furlough or reduction in work hours.*
