

1 At the locations indicated, amend the bill as follows:

2 [✓]1. Page 38, line 12: after "subdivision." insert "If an employee has a gross
3 family income that is at or below the poverty line, as defined in s. 49.001 (5),[✓] for a
4 family the size of the employee's family, the employee shall not be required to pay
5 more than 6 percent of the ^{average}~~average~~ premium cost of such plans."
