1 At the locations indicated, amend the bill as follows:

2 **1.** Page 70, line 14: after "(mm)" insert "1."

3 **2.** Page 70, line 17: delete that line and substitute:

4 "a. Section 40.02 (48)."

5 **3.** Page 70, line 18: delete "2." and substitute "b."

6 **4.** Page 70, line 18: after "subd. 1." insert "a."

7 **5.** Page 70, line 19: after that line insert:

8 "2. "Public safety employee" includes any other municipal employee who
9 performs any duty relating to law enforcement or fire suppression."

10 **6.** Page 88, line 17: delete "(am) 7. or 8." and substitute "or any person who
11 performs any duty relating to law enforcement or fire suppression."
