1 At the locations indicated, amend the bill as follows:

2 1. Page 48, line 2: after that line insert:

3 "(g) If the BadgerCare Plus program under s. 49.471, the assistance for
4 childless adults demonstration project under s. 49.45 (23), or the program that
5 provides prescription drug assistance for elderly persons under s. 49.688 is
6 eliminated under this subsection, the governor may not obtain health care coverage
7 under subch. IV of ch. 40 and any health care coverage the governor has under subch.
8 IV of ch. 40 is revoked."
