1 At the locations indicated, amend the bill as follows:

2 **1.** Page 24, line 10: after "(b)." insert "However, no sale under this subsection ✓  
3 may proceed until the public service commission approves the sale. The public  
4 service commission shall approve a sale only if it determines that the estimated  
5 increased financial obligations to the state resulting from the sale to purchase  
6 heating, cooling, and power from the purchaser during the 10-year period following  
7 the date of the sale do not exceed the proposed sales price."
