

Thank you for your assistance over the telephone this morning. I truly appreciate your professionalism; please find below the amendments I would like to sponsor:

[1] *Amend the budget to provide what the constituents one cents sales that Milwaukee County Parks, Transit and EMS

[2] *Amend the budget to provide one million dollars to the Milwaukee County Work Reform Task Force for employment and training to resolve the 50 percent unemployment effecting men of color in Milwaukee County which is the highest in the United States

[3] *Amend the budget to restore Food Share services to immigrants; I believe Rep. Young is also interested in this item also. I will give him a call.

[4] *Amend the budget to have the Wisconsin Motor Vehicle Department to collaborate with the NAACP, ACLU and UMOS in Milwaukee County to set up community outreach locations for people to come and take the ID needed for voting

[5] *Amend the budget to increase the participation by 200 people in Milwaukee County through Department of Corrections "Earned Release Program (AODA) and Work Release Program."

2 **1.** Page 220, line 10: after that line insert:

4 "SECTION 683m. 20.445 (1) (ft) of the statutes is created to read:

5 20.445 (1) (ft) *Milwaukee county task force on work reform for men.* Biennially,
6 the amounts in the schedule for grants to the county of Milwaukee under s. 106.32."

7 **3.** Page 968, line 25: after that line insert:

8 "SECTION 683m. 106.32 of the statutes is created to read:

9 **106.32 Milwaukee county task force on work reform for men.** From the
10 appropriation account under section 20.445 (1) (ft) of the statutes, the department
11 shall provide a grant in the amount of \$1,000,000 in each fiscal biennium to the

1 county of Milwaukee for that county's task force on work reform for men to assist men
2 of color in obtaining employment.”
