Senators Erpenbach and Risser have been informed we will likely be paper balloting this bill sooner than later in the Senate Committee. Because of that time frame we feel we need to move ahead with amendments to be offeren in committee as soon as possible.

Peggy, I have copied Anne and asked her to work with you, I am not sure whether or not you heard the hearing yesterday but please work together on issues/questions. You can call Terry or me anytime. My cell is 772-0110.

I have not been given information of whether we will be exec-ing on the Senate or Assembly version so please draft the amendments for both.

One - First on page 11 line 5 delete "except for" the intent is to make all records

Second – records received by DRL are open to discovery and can be used as evidence

Third – Received by DHS can be discovered but cannot be used as evidence in civil

Fourth – remove the changes to punitive damages completely

Fifth – remove the Daubert expert and non-expert testimony provisions (excluding section 37) (including section 38)

Six – take the provisions that effect damages and time limits and have them apply to act and omissions that occur on the effective date (call Anne on this!!!:))
