1. Amend bill to require that the members of the WEDC board include four legislative members, one from each party in each house, appointed by those houses; one member representing organized labor; one member who is an economic development professional practicing in Wisconsin; one member representing Wisconsin's colleges and universities; and a member representing the public at large (not sure if there's a model for this with any of the other authorities -- the idea is someone who is not a business owner or economic development person -- representing the general public).
2. Amend the bill's authorization for DOA to reassign funding and positions in Commerce to reassign all funding and positions -- the idea being that all of the non-economic development functions of Commerce be preserved and cannot be eliminated under the reassignment authority created by this act.
