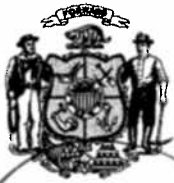
Rick --

Sen. Lassa would like to have the following amendments drafted to SS SB 6. I'm sending them to you as lead drafter of the bill; please let me know if any of this gets assigned elsewhere.

1. Amend the bill to specify that the board members, executive director, and non-clerical employees of WEDC are subject to the ethics code provisions of Ch 19 of Statutes, including the requirement to file statements of economic interest (our models here would be WHEDA and the Dairy Center Authority).
2. Amend the bill to specify that WEDC is subject to the requirements that were imposed on Commerce and other state agencies with economic development programs in 2007 Act 125.
3. Amend the bill to require that the non-executive employees of WEDC be civil service employees (our model here is the UW Hospitals authority) and subject to other protections currently enjoyed by state employees.
4. Amend the bill to specify that no employee drawing a salary from WEDC can simultaneously draw a salary from any other state agency.

There will undoubtedly be more to come. I look forward to your questions!

SENATE AMENDMENT,
TO SENATE BILL 6

1 At the locations indicated, amend the bill as follows:

2 1. Page 5, line 25: after that line insert:

3 "SECTION 11m. 16.03 of the statutes is created to read:

4 **16.03 Contractual services agreement with the Wisconsin Economic**
5 **Development Corporation.** (1) In this section, "board" means the board of the
6 Wisconsin Economic Development Corporation.

7 (2) The secretary shall enter into a contractual services agreement with the
8 board to provide employee services for the board under s. 238.045.

9 (3) (a) Any contractual services agreement under sub. (2) may include a
10 provision that authorizes the board to perform specified duties for the department
11 with respect to employees of the department. This authorization may include duties
12 related to supervising employees, taking disciplinary action, or recommending new

1 hires or layoffs, or with respect to collective bargaining, claims, complaints, or
2 benefits and records administration.

3 (b) Any authorization under par. (a) shall comply with all applicable provisions
4 of subch. V of ch. 111 and ch. 230, any delegation of authority by the office of state
5 employment relations to the department, and any collective bargaining agreement
6 with respect to employees of the department.”.

7 **2.** Page 6, line 23: after that line insert:

8 “**SECTION 15m.** 20.505 (1) (gp) of the statutes is created to read:

9 20.505 (1) (gp) *Contractual services agreement with Wisconsin Economic*
10 *Development Corporation.* All moneys received from the Wisconsin Economic
11 Development Corporation under any contractual services agreement entered into
12 under s. 16.03 (2) to provide employee services for the Wisconsin Economic
13 Development Corporation.”

14 **3.** Page 20, line 7: delete “Employ” and substitute “Subject to s. 238.045,
15 employ”.

16 **4.** Page 20, line 14: after that line insert:

17 “**238.045 Contractual services agreement with the department of**
18 **administration.** The board shall contract with the department of administration
19 under s. 16.03 (2) for all employee services of the corporation, except for executive,
20 supervisory, and managerial employee services.”.

21 **5.** Page 21, line 23: after “statutes” insert “, or transfer any such position or
22 portion thereof to the department of administration to be funded from revenues
23 appropriated under section 20.505 (1) (gp) of the statutes, as created by this act”.
