1 At the locations indicated, amend the bill as follows:

2 **1.** Page 18, line [✓]24: delete the material beginning with “consist of” and ending
3 with “The secretary” on page 19, line 1, and substitute “consist of the following:

4 (a) The governor.

5 (b) One majority party member and one minority party member from each
6 house of the legislature, appointed as are the members of standing committees in
7 their respective houses.

8 (c) One member representing labor, nominated by the governor and, with the
9 advice and consent of the senate, appointed.

10 (d) One member who is an economic development professional practicing in
11 Wisconsin, nominated by the governor and, with the advice and consent of the
12 senate, appointed.
