**SENATE AMENDMENT ,
TO SENATE BILL 6**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 20, line 14: after that line insert:

3 **"238.045 Wisconsin job retention.** (1) Any recipient of a grant, loan, or
4 award under this chapter shall enter into an agreement with the ^{board} corporation that
5 requires that a new job created as a result of that grant, loan, or award shall be
6 located in Wisconsin and shall be continuously occupied and retained in Wisconsin
7 for not less than 4 years.

8 (2) The terms of the agreement under sub. (1) shall include a provision
9 requiring the recipient to repay to the corporation all or a portion of the grant, loan,
10 or award if the recipient fails to meet the agreement's requirements under sub. (1)."
