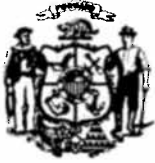

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1 **SECTION 1.** 1.12 (1) (b) of the statutes is amended to read:

2 1.12 (1) (b) "State agency" means an office, department, agency, institution of
3 higher education, the legislature, a legislative service agency, the courts, a judicial
4 branch agency, an association, society, or other body in state government that is
5 created or authorized to be created by the constitution or by law, for which
6 appropriations are made by law, excluding the Health Insurance Risk-Sharing Plan
7 Authority and the Wisconsin Economic Development Corporation.

8 **SECTION 2.** 13.172 (1) of the statutes is amended to read:

9 13.172 (1) In this section, "agency" means an office, department, agency,
10 institution of higher education, association, society, or other body in state
11 government created or authorized to be created by the constitution or any law, that
12 is entitled to expend moneys appropriated by law, including the legislature and the
13 courts, and any authority created in subch. II of ch. 114 or subch. III of ch. 149 or in
14 ch. 52, 231, 233, 234, 238, or 279.

15 **SECTION 3.** 13.48 (10) (b) 6. of the statutes is created to read:

16 13.48 (10) (b) 6. Projects of the Wisconsin Economic Development Corporation.

17 **SECTION 4.** 13.48 (12) (b) 5. of the statutes is created to read:

18 13.48 (12) (b) 5. A facility constructed by or for the Wisconsin Economic
19 Development Corporation.

20 **SECTION 5.** 13.48 (13) (a) of the statutes is amended to read:

21 13.48 (13) (a) Except as provided in par. (b) or (c), every building, structure or
22 facility that is constructed for the benefit of or use of the state, any state agency,
23 board, commission or department, the University of Wisconsin Hospitals and Clinics
24 Authority, the Fox River Navigational System Authority, the Wisconsin Quality
25 Home Care Authority, the Wisconsin Economic Development Corporation, or any

1 local professional baseball park district created under subch. III of ch. 229 if the
2 construction is undertaken by the department of administration on behalf of the
3 district, shall be in compliance with all applicable state laws, rules, codes and
4 regulations but the construction is not subject to the ordinances or regulations of the
5 municipality in which the construction takes place except zoning, including without
6 limitation because of enumeration ordinances or regulations relating to materials
7 used, permits, supervision of construction or installation, payment of permit fees, or
8 other restrictions.

9 **SECTION 6.** 13.62 (2) of the statutes is amended to read:

10 13.62 (2) "Agency" means any board, commission, department, office, society,
11 institution of higher education, council, or committee in the state government, or any
12 authority created in subch. II of ch. 114 or subch. III of ch. 149 or in ch. 52, 231, 232,

14 committee of the legislature.

15 **SECTION 7.** 13.94 (1) (dr) of the statutes is created to read:

18 the Wisconsin Economic Development Corporation under ch. 238. The legislative
19 audit bureau shall file a copy of each audit report under this paragraph with the
20 distributees specified in par. (b).

12 credentialing board, commission, independent agency, council or office in the
13 executive branch of state government; all bodies created by the legislature in the
14 legislative or judicial branch of state government; any public body corporate and
15 politic created by the legislature including specifically the Wisconsin Quality Home
16 Care Authority, the Fox River Navigational System Authority, the Lower Fox River
17 Remediation Authority, and the Wisconsin Aerospace Authority, the Wisconsin
18 Economic Development Corporation, a professional baseball park district, a local
19 professional football stadium district, a local cultural arts district and a long-term
20 care district under s. 46.2895; every Wisconsin works agency under subch. III of ch.
21 49; every provider of medical assistance under subch. IV of ch. 49; technical college
22 district boards; every county department under s. 51.42 or 51.437; every nonprofit
23 corporation or cooperative or unincorporated cooperative association to which
24 moneys are specifically appropriated by state law; and every corporation, institution,
25 association or other organization which receives more than 50% of its annual budget

1 from appropriations made by state law, including subgrantee or subcontractor
2 recipients of such funds.

3 SECTION 11. 13.95 (intro.) of the statutes is amended to read:

4 13.95 Legislative fiscal bureau. (intro.) There is created a bureau to be
5 known as the "Legislative Fiscal Bureau" headed by a director. The fiscal bureau
6 shall be strictly nonpartisan and shall at all times observe the confidential nature
7 of the research requests received by it; however, with the prior approval of the
8 requester in each instance, the bureau may duplicate the results of its research for
9 distribution. Subject to s. 230.35 (4) (a) and (f), the director or the director's
10 designated employees shall at all times, with or without notice, have access to all
