SENATE TO ASSEMBLY SUBSTITUTE AMENDMENT *1*,
SENATE TO ASSEMBLY BILL 6

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 25, line 12: delete "Before" and substitute "(a) Except as provided in
3 paragraph (b), before".

4 2. Page 25, line 20: after that line insert:

5 "(b) The secretary of administration shall not transfer any moneys under
6 ~~paragraph (a) unless legislation is first enacted by the legislature that creates~~ *the board of directors of the Wisconsin Economic Development Corporation first prescribes*
7 standards of ethical conduct and filing requirements for employees of the Wisconsin
8 Economic Development Corporation that are at least as stringent as the standards
9 and requirements that applied to the employees of the department of commerce who
10 held positions that were comparable to those held by the employees of the corporation
11 immediately before the effective date of this paragraph." *and the board provides written notice to the chief clerk of each house of the legislature and to the secretary of administration certifying that the standards and requirements are in effect*
