Hi Rick and Chris,

Mark in our office has been working with you on three amendments for today's session on Special Session Senate Bill 6. I am not sure who is in/who is making it in today, so I just wanted to double check that these amendments are on the radar to be finished in time for the floor today.

- 1) This amendment inserts provisions from Act 125 that require Commerce to report jobs created by location and jobs created by industry cluster to make them apply to WEDC,.
- 2) Require the Department of Commerce to provide notice to any entities they are working with of any cancellation of programs that those entities are receiving or negotiating with 15 days prior to Commerce moving money out of accounts
- 3) Regardless of what WEDC does under the bill, it cannot stop funding regional economic development entities

Don't worry about contacting me unless there is a problem with getting these three amendments before going to the floor.
