Rick –

Please draft the following amendments to the versions of SS SB 6 and SS AB 6 that will be on the Senate Floor tomorrow:

1. Identical to a0239/1, except specify that the executive director of WEDC may not be employed at the same time by a state agency.
2. Identical to a0236/1
3. Identical to a0278/1
4. An amendment to require Commerce to send written notice to any entity either currently funded by Commerce if it will lose funding as a result of the transfer of funds to WEDC; and to any entity currently in negotiation with Commerce if programs involved in those negotiations are to be defunded as the result of the transfer.
5. An amendment to prohibit the transfer of funds under the bill until the Legislature creates ethics provisions for WEDC employees that are at least as stringent as those currently required of Commerce. (Background: apparently the bill can't currently be amended to extend public service ethics requirements beyond the executive director and board members because WEDC has no staff structure yet. The idea behind the amendment is that the structure would have to be created and a statute adopted that requires ethics and financial reporting requirements for the same levels of administrative staff as Commerce before DOA can transfer funds).

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 6, line 22: after that line insert:

3 "SECTION 15m. 16.03 of the statutes is created to read:

4 **16.03 Contractual services agreement with the Wisconsin Economic**

5 **Development Corporation. (1)** In this section, "board" means the board of the

6 Wisconsin Economic Development Corporation.

7 **(2)** The secretary shall enter into a contractual services agreement with the

8 board to provide employee services for the board under s. 238.045.

9 **(3)** (a) Any contractual services agreement under sub. (2) may include a

10 provision that authorizes the board to perform specified duties for the department

11 with respect to employees of the department. This authorization may include duties

12 related to supervising employees, taking disciplinary action, or recommending new

1 hires or layoffs, or with respect to collective bargaining, claims, complaints, or  
2 benefits and records administration.

3 (b) Any authorization under par. (a) shall comply with all applicable provisions  
4 of subch. V of ch. 111 and ch. 230, any delegation of authority by the office of state  
5 employment relations to the department, and any collective bargaining agreement  
6 with respect to employees of the department.”.

7 **2.** Page 16, line 11: after that line insert:

8 “**SECTION 38m.** 20.505 (1) (gp) of the statutes is created to read:

9 20.505 (1) (gp) *Contractual services agreement with Wisconsin Economic*  
10 *Development Corporation.* All moneys received from the Wisconsin Economic  
11 Development Corporation under any contractual services agreement entered into  
12 under s. 16.03 (2) to provide employee services for the Wisconsin Economic  
13 Development Corporation.”.

14 **3.** Page 23, line 1: delete “Employ” and substitute “Subject to s. 238.045,  
15 employ”.

16 **4.** Page 23, line 8: after that line insert:

17 “**238.045 Contractual services agreement with the department of**  
18 **administration.** The board shall contract with the department of administration  
19 under s. 16.03 (2) for all employee services of the corporation, except for executive,  
20 supervisory, and managerial employee services.”.

21 **5.** Page 25, line 8: after “statutes” insert “, or transfer any such position or  
22 portion thereof to the department of administration to be funded from revenues  
23 appropriated under section 20.505 (1) (gp) of the statutes, as created by this act.”.
