

- 1 At the locations indicated, amend the substitute amendment as follows:
- 2 **1.** Page 23, line 3: after "obligations" insert ", subject to s. 238.065". ✓
- 3 **2.** Page 23 line (18) (14): after that line insert:
- 4 **"238.065 Bonding authority.** Any note, bond, or other obligation the board
- 5 issues shall be authorized by resolution of the members of the board. No less than
- 6 14 days prior to any commitment by the board for the issuance of a note, bond, or
- 7 other obligation under this section, the board shall submit that resolution to the
- 8 cochairpersons of the joint committee on finance. If, within 14 days after the date
- 9 on which the resolution is submitted to the joint committee on finance, the
- 10 cochairpersons of the committee do not notify the board that the committee has
- 11 scheduled a meeting for the purpose of reviewing the resolution, the board may
- 12 proceed with any commitment for the issuance of notes, bonds, or other obligations

1 under the resolution. If, within 14 days after the date on which the resolution is  
2 submitted to the committee, the cochairpersons of the committee notify the board  
3 that the committee has scheduled a meeting to review the resolution, the board may  
4 proceed with any commitment for the issuance of notes, bonds, or other obligations  
5 under the resolution only upon approval by the committee.”
