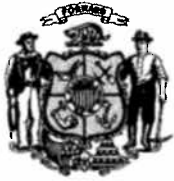

5 created in the department of commerce a division of environmental and regulatory
6 services. The administrator of this division shall be appointed outside the classified
7 service by the secretary and shall serve at the pleasure of the secretary. (c) 2
