3 "SECTION 22m. 632.32 (5) (i) 2. [✓] of the statutes is created to read:

4 632.32 (5) (i) 2. If a policy contains a provision that reduces the limits for
5 uninsured motorist coverage or underinsured motorist coverage as permitted under
6 subd. 1., the insurer shall provide notice of the provision and an explanation of the
7 effect of the provision to any person who applies for insurance under such a policy.
8 If a policy that is in effect before the effective date of this subdivision [LRB inserts
9 date], does not contain a provision permitted under subd. 1. but will contain such a
10 provision when renewed, the insurer shall provide the notice and explanation to one
11 insured under the policy in conjunction with the notice of that renewal.
