TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 8

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 2, line 8: after "rules;" insert "campaign contributions by lobbyists who
3 attempt to influence rule making;"

4 **2.** Page 7, line 1: before that line insert:

5 **"SECTION 13.625 (1) (c) (intro.)** of the statutes is amended to read:

6 13.625 (1) (c) (intro.) Except as permitted in this subsection, make a campaign
7 contribution, as defined in s. 11.01 (6), to a partisan elective state official for the
8 purpose of promoting the official's election to any national, state or local office, or to
9 a candidate for a partisan elective state office to be filled at the general election or
10 a special election, or the official's or candidate's personal campaign committee. A
11 campaign contribution to a partisan elective state official or candidate for partisan

1 elective state office or his or her personal campaign committee may be made in the
2 year of a candidate's election between June 1 and the day of the general election,
3 except that no lobbyist who attempts to influence administrative action may make
4 a contribution to the governor at any time and except that:".
