ASSEMBLY BILL 7

Modification to Bill

Motion:

Move to make the following amendments to LRBs01000/1:

- Specify that as proof of residency a student may use a college ID that does not contain a current address as proof of residence if the college or university provides a certified and current list of students who reside in college housing and are United States citizens to the municipal clerk, or if the student presents his or her student ID together with a fee payment receipt dated no earlier than nine months before the date of the election.
- Specify that provisions related to in-person absentee voting and voter registration requirements would apply to elections that take place on or after the effective date of the bill.

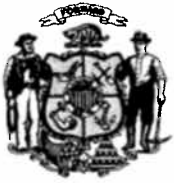
