3 "SECTION ~~202~~<sup>108</sup>m. 110.085 of the statutes is created to read:

4 **110.085 Temporary or mobile examining stations.** (1) The department  
5 shall operate temporary or mobile examining stations, during the period specified in  
6 sub. (2), on the campus of each university or college in this state that is accredited,  
7 as defined in s. 39.30 (1) (d), including any technical college, at which the department  
8 shall receive applications and issue operator's licenses under ch. 343 and  
9 identification cards under s. 343.50 or driving receipts under s. 343.11 and  
10 identification card receipts under s. 343.50 (1) (c).

11 (2) Examining stations under sub. (1) shall be operated on any campus  
12 specified in sub. (1) when any election is held in the county where the campus is

1 located and shall be open for business until at least 9 p.m. on each weekday during  
2 the week of the election and the week immediately preceding the election and after  
3 the election until the deadline described in s. 6.97 (3) (b). At these examining  
4 stations, the department shall provide priority service to applicants seeking  
5 identification for voting.”.
