

2 **1.** Page *12*, line 1: before that line insert:

3 "SECTION 1. 5.02 (1w) of the statutes is created to read:

4 5.02 (1w) "Conform," when used with reference to the name of an individual
5 that appears on proof of identification, includes, but is not limited to, a substantially
6 similar name, a nickname, initials substituted for the first or middle name, a
7 misspelled name, a shortened or informal form of a name, a slightly erroneous
8 version of a name, a name that appears to contain a transposition error, and a name
9 that includes or excludes a suffix or hyphenation that should or should not appear."

10 **2.** Page *12*, line 1: delete "SECTION 1" and substitute "SECTION 1m".
