



**ASSEMBLY AMENDMENT 32,
TO ASSEMBLY SUBSTITUTE AMENDMENT 2,
TO 2011 ASSEMBLY BILL 7**

May 11, 2011 – Offered by Representatives ROYS, YOUNG and E. COGGS.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 9, line 15: delete lines 15 to 18.

3 **2.** Page 14, line 2: delete “6.34.” and substitute “6.34 or, if the elector presents
4 student identification under s. 5.02 (6m) (f), have his or her residence corroborated
5 by another elector of the municipality in the manner provided in par. (d) 1r.”.

6 **3.** Page 14, line 8: delete the material beginning with “require” and ending
7 with “6.34” on line 13 and substitute “require the elector to provide proof of residence
8 under s. 6.34. If the elector cannot provide proof of residence and the elector presents
9 student identification under s. 5.02 (6m) (f), the elector may have his or her residence
10 corroborated in a statement that is signed by another elector of the municipality and
11 that contains the current street address of the corroborating elector. If the residence
12 is corroborated by another elector, that elector shall then provide proof of residence

1 under s. 6.34. If the elector provides proof of residence or a corroborator corroborates
2 the elector’s residence, the clerk shall”.

3 **4.** Page 15, line 4: after “residence” insert “or corroboration of residence”.

4 **5.** Page 20, line 6: delete the material beginning with “Alternatively” and
5 ending with “6.34.” on line 10 and substitute “Alternatively, if the elector is unable
6 to provide proof of residence under s. 6.34, and the elector presents student
7 identification under s. 5.02 (6m) (f), the information contained in the registration
8 form shall be corroborated in a statement that is signed by any other elector of the
9 municipality and that contains the current street address of the corroborating
10 elector. The corroborating elector shall then provide proof of residence under s.
11 6.34.”.

12 **6.** Page 21, line 5: delete “~~and the signature of any corroborating elector~~” and
13 substitute “and the signature of any corroborating elector”.

14 **7.** Page 21, line 23: delete the material beginning with that line and ending
15 with page 22, line 3.

16 **8.** Page 25, line 18: delete the material beginning with “If” and ending with
17 “6.34.” on line 23 and substitute “If the elector cannot provide proof of residence and
18 the elector presents student identification under s. 5.02 (6m) (f), the information
19 contained in the registration form shall be corroborated in a statement that is signed
20 by any elector who resides in the same municipality as the registering elector and
21 that contains the current street address of the corroborating elector. The
22 corroborator shall then provide proof of residence as provided in s. 6.34.”.

23 **9.** Page 26, line 2: delete “~~and by any corroborator~~” and substitute “and by any
24 corroborator”.

1 **10.** Page 26, line 19: delete the material beginning with “If” and ending with
2 “(b).” on line 21 and substitute “If the elector cannot provide proof of residence and
3 the elector presents student identification under s. 5.02 (6m) (f), the information
4 contained in the registration form shall be corroborated in the manner provided in
5 par. (b).”.

6 **11.** Page 27, line 1: delete “~~and by any corroborator~~” and substitute “and by
7 any corroborator”.

8 **12.** Page 27, line 19: delete that line.

9 **13.** Page 30, line 14: delete the material beginning with “When” and ending
10 with “(e).” on line 19, and substitute “When any elector corroborates the registration
11 identity or residence of any person offering to vote under s. 6.55 (2) (b) or (c), or the
12 registration identity or residence of any person registering on election day under s.
13 6.86 (3) (a) 2., the election officials shall also enter the name and address of the
14 corroborator next to the name of the elector whose information is being corroborated
15 on the poll list, or the separate list maintained under sub. (2) (c).”.

16 **14.** Page 35, line 25: delete the material beginning with “~~and~~” and ending with
17 “~~address~~” on page 36, line 2, and substitute “and any other elector residing in the
18 same municipality as the hospitalized elector, corroborating the information
19 contained therein. The corroborating elector shall state on the form his or her full
20 name and address”.

21 **15.** Page 37, line 5: delete the material beginning with “If” and ending with
22 “~~6.34.~~” on line 10 and substitute “If the agent cannot present proof of residence and
23 the elector is presenting student identification under s. 5.02 (6m) (f), the registration
24 form shall be signed and substantiated by another elector residing in the elector’s
