

Rep. Pasch would like to request the following amendments to the JFC sub to AB 7:

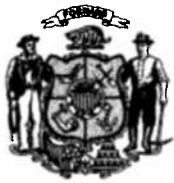
- 
- Expand allowable forms of identification to include Medicaid, Medicare, or SSI cards
 - Remove requirement for authorized representative of care facilities to sign absentee ballots cast by mail
 - Require municipal clerks to send a notice to electors who do not return an absentee ballot indicating that the voters will not receive a ballot in the next election unless they follow the instructions outlined in the notice. These notices shall be mailed within three weeks after the missed election.
 - Reinstate the GAB's ability to appoint special registration deputies
 - State that a person with a disability that impairs his or her ability to fulfill the signature requirement be permitted to ask the poll worker to automatically exempt the voter from the requirement, initial on the poll list to indicate that the reasonable accommodation was provided, and allow the voter to vote by regular ballot.

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 9, line 8: after that line insert:

3 “(g) A card issued by the federal social security administration that shows proof
4 of eligibility for the Medicare program; a card that is issued by the department of
5 health services and is known as a ForwardHealth card and that shows proof of
6 eligibility for the Medical Assistance program; or any card that shows eligibility for
7 the supplemental security income program under 42 USC 1381 to 1383d.”
