1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 13, line 25: after "applicant" insert "who resides in a city having a
3 population of ~~20,000 or more~~ ^{500,000 or less} or a village or town".

4 2. Page 15, line 21: after "applicant" insert "resides in a city having a
5 population of ~~less than 20,000~~ ^{more than 500,000} or".

6 3. Page 28, line 10: after "elector" insert "who resides in a (a) city having a
7 population of ~~20,000 or more~~ ^{500,000 or less} or a village or town".

8 4. Page 30, line 1: after "If" insert "any required".

9 5. Page 31, line 19: after "(7)," insert "if the elector resides in a city having a
10 population of ~~20,000 or more~~ ^{500,000 or less} or a village or town".
