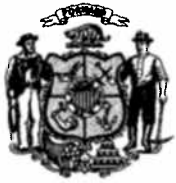
Hi Jeff,

- 2 √ 1. Page 28, line 17: after "requirement under" insert "par. (am) or".
- 3 2. Page 28, line 22: after "(am)" insert "If an elector states to the officials that
- 4 he or she is illiterate, the officials shall waive the signature requirement. In this
- 5 case, the officials shall enter next to the name and address of the elector on the poll,
- 6 supplemental, or separate list the word "exempt".
