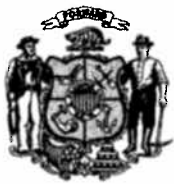

TO ASSEMBLY SUBSTITUTE AMENDMENT 2,

TO 2011 ASSEMBLY BILL 7

1 At the locations indicated, amend the substitute amendment as follows:

2 √ 1. Page 2, line 18: after "activities;" insert "posting of election returns;"

3 √ 2. Page 61, line 5: after that line insert:

4 "SECTION 102m?. 7.60 (1) of the statutes is amended to read:

5 7.60 (1) KEEP OFFICE OPEN AND POST RETURNS. On election night the county clerk

6 shall keep the clerk's office open to receive reports from the ward inspectors and shall

7 post all returns by ward electronically on the Internet."
