5 with “and” on line 23 and substitute “states to the inspectors that he or she”.

6 **3.** Page 28, line 25: delete the material beginning with “if” and ending with
7 “signature” on page 29, line 1.

8 **4.** Page 29, line 3: delete lines 3 to 9 and substitute “word “exempt.””.
