**SENATE AMENDMENT 13,  
TO 2011 ASSEMBLY BILL 7**

May 17, 2011 – Offered by Senators JAUCH, ERPENBACH, TAYLOR, CARPENTER, HOLPERIN, C. LARSON, T. CULLEN, S. COGGS, RISSER, MILLER, VINEHOUT and HANSEN.

- 1           At the locations indicated, amend the bill, as shown by assembly substitute  
2           amendment 2, as follows:
- 3           **1.** Page 2, line 15: delete “voting a”.
  - 4           **2.** Page 2, line 16: delete “straight party ticket;”.
  - 5           **3.** Page 9, line 23: delete the material beginning with that line and ending with  
6           page 11, line 5.
  - 7           **4.** Page 11, line 6: delete lines 6 to 15.
  - 8           **5.** Page 11, line 19: delete “~~10 28~~” and substitute “10”.
  - 9           **6.** Page 11, line 23: delete the material beginning with “~~10 his~~” and ending  
10          with “~~28~~” on line 24 and substitute “his or her residence later than 10”.
  - 11          **7.** Page 12, line 1: delete lines 1 to 13.
  - 12          **8.** Page 12, line 17: delete “~~10 28 consecutive~~” and substitute “10”.

1           **9.** Page 12, line 21: delete the material beginning with that line and ending  
2 with page 13, line 22.

3           **10.** Page 16, line 15: delete “10 28 consecutive” and substitute “10”.

4           **11.** Page 17, line 21: delete lines 21 to 24.

5           **12.** Page 20, line 4: delete “10 28 consecutive” and substitute “10”.

6           **13.** Page 20, line 25: delete “10 28 consecutive” and substitute “10”.

7           **14.** Page 24, line 22: delete “10 28 consecutive” and substitute “10”.

8           **15.** Page 25, line 3: delete lines 3 to 15.

9           **16.** Page 32, line 14: delete lines 14 to 23 and substitute:

10           “**SECTION 87m.** 6.85 of the statutes is amended to read:

11           **6.85 Absent elector; ~~definition~~ electors.** **(1)** An absent elector is any  
12 otherwise qualified elector who for any reason is unable or unwilling to appear at the  
13 polling place in his or her ward or election district.

14           **(2)** Any otherwise qualified elector who changes residence within this state by  
15 moving to a different ward or municipality later than 10 days prior to an election may  
16 vote an absentee ballot in the ward or municipality where he or she was qualified to  
17 vote before moving.

18           **(3)** An absent elector qualifying under this section may vote by absentee ballot  
19 under ss. 6.86 to 6.89.”.

20           **17.** Page 33, line 17: delete the material beginning with “no” and ending with  
21 “Friday” on line 19 and substitute “no later than 5 p.m. on the day”.

22           **18.** Page 40, line 2: delete “10 later than 28” and substitute “later than 10”.
