Hi Jeff,

On the first bullet, how late in the evening does the DMV office need to stay open? Also, do you want the amendment to apply for the *calendar month* before the election or for *30 days prior* to the election?

On the second bullet, I'm not sure what you mean by "voter specific IDs." To my knowledge, there are no "voter specific IDs" in AB-7. (The forms of identification are listed from p. 8 line 1 to p. 9 line 8 of ASA2 to AB-7, as affected by AA1.) Moreover, I believe that all of the forms of ID mentioned in the bill are either presently being issued or will be issued upon publication of the bill.

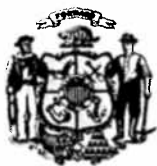
