1. Page <sup>77</sup>~~75~~, line 10: after that line insert:

“(4) POSTING OF INFORMATION FOR ELECTORS BY ~~G~~OVERNMENT ~~A~~CCOUNTABILITY BOARD. No later than 14 days after the effective date of this subsection, the ~~G~~overnment ~~A~~ccountability Board shall post on the Internet not more than 2 pages of material succinctly summarizing all requirements for electors to register and to vote, including absentee balloting requirements, that are affected by this act and shall update the posting periodically as needed to maintain its usefulness. The posting shall have a Flesch readability score of 55 or higher.”
